Old Business: The minutes from the prior meeting which were previously distributed to the members by email were offered for approval. B. Michael made a motion for the minutes to be approved. The motion was seconded by D. Neil. With all those in attendance voting in approval, the motion was passed.

Treasurer's Report:

- [The 2015 club dues are currently being collected.
- [24 paid members as of February 7, 2015.
- [Treasury currently has \$1,611.33 after Christmas party expenses. Christmas party expenses totaled approximately \$520.00

Events Report:

- [International Car Show was held on the first weekend in January. The Club has been well received and it is anticipated that we will be invited to participate in the future.
- [Seven members displayed cars at the International Car Show.
- [The renovation of the Civic Center opens the possibility that our cars will be on display in the lower level.
- [World of Wheels Auto Show will be held at the Big Sandy Super Center March 6-8.
- [R. Stephenson is working on the Summit.
- [R. Reese will be traveling to Chicago for the British Car Club Swap Meet held on Sunday March 15th.
- [On first weekend in June Moss Motors meet will be held in Leesburg, VA.
- [British Car show will be held in Columbus, OH the first weekend of May.

- [President requested volunteers to plan Club road trips for this coming year. Those that volunteered for this committee are K. Worthy, M. Mason, and B. Michael.
- [President requested volunteers to participate on the Tech Session Committee. Those members who volunteered are R. Reese, D. King, K. Worthy, J. Chenoweth and E. Arentz.
- [S. Ewing suggested doing tech sessions at the Putnam County Vocational Center or R. Reese's garage.

New Business:

- [It is suggested that the club drive to a community event at the Racine city park in Racine, OH. Money raised during this event goes to a local scholarship. Racine Community Center is the sponsor of this event, which is held on the second Saturday of September. The event includes a car show.
- [M. Mason suggests name tags for members to wear during meetings. B. Michael volunteers to prepare name tags.
- [D. Blackwood reports on House Bill 2503 that has been introduced in the Legislature requiring all antique cars to be valued at \$5,000.00. House Bill 2503 currently before the Transportation Committee.
